**QUALITY REPAIRS DON'T
HAPPEN BY ACCIDENT.**

Nobody wants to be in an accident, especially when it involves costly or incorrect repairs and insurance hassles. So, take a minute and read the following guide. You'll find that when you prepare yourself, you protect your vehicle.

KNOW THE TERMINOLOGY

Understanding the language in your policy is crucial to knowing just how protected you are.

ORIGINAL EQUIPMENT MANUFACTURER (OEM) PARTS — The parts your vehicle rolled off the assembly line with. In regard to your vehicle, OEM parts are Authentic Chrysler Collision Repair Parts by Mopar, the parts division of Chrysler LLC. Repairs with Mopar parts help maintain a vehicle's value.

AFTERMARKET PARTS — Parts not made by the Original Equipment Manufacturer. Typically, such parts are made to fit many vehicles and are not required to meet the same federal specifications as OEM parts. As a result, many do not measure up in regard to materials used, assembly or fit.

SALVAGE OR USED PARTS — Mostly these are crash parts recovered from totaled or otherwise disabled vehicles. Hidden damage, improper removal techniques and unsuitable storage raise quality concerns about such parts.

PHRASES TO TAKE NOTE OF —

- We may, at our discretion, repair or replace with parts of a like kind, including quality salvage and non-OEM parts
- We are not required to return the vehicle to the pre-accident market value

KNOW YOUR RIGHTS

Insurers are not obligated to notify you that replacement parts are of lesser quality or categorically inferior. Additionally, many insurers are increasing use of non-OEM parts. So, it is more important than ever to know just what you're entitled to should your vehicle need collision repairs.

- It's your right to ask your insurer or body shop for Authentic Chrysler Collision Repair Parts by Mopar
- You have the right to choose your own repair facility
- It's your right to know. Disclosure laws in most states require insurance companies and repair facilities to inform you if they plan on using aftermarket or salvage parts for repairs

OEM PARTS MAINTAIN VEHICLE VALUE

Always insist on OEM parts for the following reasons:

- Authentic Chrysler Collision Repair Parts by Mopar are the parts your car rolled off the assembly line with — manufactured with the same tools and dies and stamping presses of the parts currently on your vehicle

- As OEM parts, Authentic Chrysler Collision Repair Parts by Mopar meet the same rigorous safety and security specs as the original parts your vehicle was born with.
Note: No laws currently govern the crashworthiness of aftermarket collision parts
- Authentic Chrysler Collision Repair Parts by Mopar are designed, engineered and tested by the original manufacturer to operate seamlessly with your vehicle's other systems
- Authentic Chrysler Collision Repair Parts by Mopar are warranted* for as long as you own your vehicle
