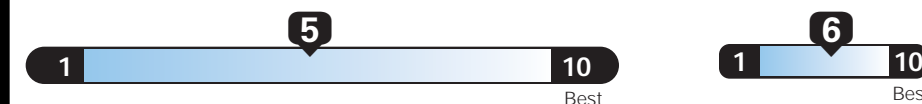

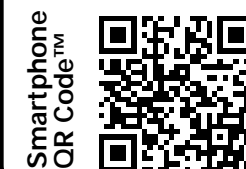

### Bumper Performance
